III. REFERENTIAL USED

> The assessment of conformity was conducted taking also into account the provisions of European standard EN 1496 of February 2017 "Personal fall protection equipment – Rescue lifting devices".

IV. CONDITION FOR USE OF THE EQUIPMENT

This rescue lifting device of class B is intended to be used, in combination with other components, as personal protective equipment against falls from a height planned for the rescue operation.

V. DESCRIPTION

➤ Rescue lifting and lowering device class B in galvanized steel 220 wire cable, diameter 4.9mm, 7X19, working length 30m. The cable end with a thimbled buckle and equipped by an energy absorber. Energy absorber with wrench webbing in polyamide/polyester, width 45mm, with a sewn buckle, protected by thermoretractable sheath and integrated connector M47 with swivel and locking gate device by safety catch. On the housing side, a mounting bracket reference 200368 (which enables installation of the B20 R ESD 150 KG M47 + CONSOLE to the safety tripods reference TRACPODE). Exclusively vertical use. Maximum rated load 150kg (detailed description in file and in the report of conformity 17.0146).

VI. CONCLUSION

➤ The rescue lifting device trademark "TRACTEL", model "B30 R ESD 150kg M47 + CONSOLE" reference "076032" conforms to the requirements of the standard EN 1496 of February 2017 and with the conformity of manufacturer's technical file.
